Code section 54950, et seq.), **Board action or discussion cannot be taken** on non-agenda matters, but the Board may briefly respond to statements or questions and, if deemed necessary, refer the subject matter to the appropriate department for follow-up and/or to schedule the matter on a subsequent Board Agenda.

C3 Air Quality Management District:

Adopt a resolution which: (1) Approves and authorizes the Air Quality Management District (District) to apply for and accept an application for Carl Moyer Program Year 17, Fiscal Year 2014-15 funds in the amount of \$312,413, with a District match in an amount not to exceed \$50,000; (2) approves and authorizes the Director of Resource Management to sign the application, subsequent agreement, and other necessary documents; (3) authorizes expenditures for operation of the program; and (4) authorizes acceptance of any qualified project and administrative funds awarded to the District through the Rural Assistance Program through Fiscal Year 2015-16 (no General Fund impact).
