C2 **Air Quality Management District:** Take the following actions: (1) Adopt a resolution which authorizes the Air Quality Management District to apply for and accept excess Carl Moyer Program Funds for Fiscal Year 2011-12 in the amount of \$96,704 plus \$5,000 in administration funding; and (2) approve a budget amendment increasing appropriations by \$96,704 and revenues by \$101,704 in the Air Quality Management District budget (4/5 vote required; no General Fund impact).

C3 **Resource Management:** Approve and authorize the Chairman to sign an amendment to the agreement with AECOM Technical Services, Inc. with no increased compensation modifying the Project Scope of Work, Schedule, and Payment Schedule for the Regional Climate Action Plan and extending the term to June 30, 2012 (no General Fund impact).
