Code section 54950 et seq.), **action or Board discussion cannot be taken** on open time matters other than to receive the comments and, if deemed necessary, to refer the subject matter to the appropriate department for follow-up and/or to schedule the matter on a subsequent Board Agenda.

RESOURCE MANAGEMENT

- C3 Air Quality Management District:** Adopt a resolution which: (1) Approves and authorizes the Air Quality Management District (District) to apply for and accept an application for Carl Moyer Program Year 16, Fiscal Year 2013-14 funds in the amount of \$307,726, with a District match in an amount not to exceed \$50,000; (2) approves and authorizes the Director of Resource Management to sign the application, subsequent agreement, and other necessary documents; and (3) authorizes expenditures for operation of the program (no General Fund impact).

R1 **Air Quality Management District:** Consider adopting a resolution which: (1) Approves the transfer of up to 25.086 tons per year of Volatile Organic Compound Emission Reduction Credits to the Yolo-Solano Air Quality Management District; and (2) finds that the proposed action is categorically exempt from the California Environmental Quality Act (CEQA) (no General Fund impact).
