

**NOTICE OF INTENT TO ADOPT A  
MITIGATED NEGATIVE DECLARATION OR NEGATIVE DECLARATION  
AND NOTICE OF PUBLIC HEARING BY  
THE SHASTA COUNTY PLANNING COMMISSION**

**NOTICE IS HEREBY GIVEN** that the Planning Commission of the County of Shasta, State of California, will consider recommended environmental determinations and hold a public hearing on whether to approve, conditionally approve, or deny the projects described in this notice. A public hearing to consider the listed projects will be held on **Thursday, October 13, 2016, with the session beginning at 2:00 p.m.**, or as soon thereafter as the business of the Commission will allow. The projects will not necessarily be heard in the order listed in this notice. The hearing will be conducted at the Board of Supervisors' Chambers located at 1450 Court Street, Room 263, Redding, California.

Based on a preliminary analysis, the Shasta County Planning Commission, as lead agency, intends to adopt a Mitigated Negative Declaration or Negative Declaration for each of the projects listed below in this notice. A Mitigated Negative Declaration or Negative Declaration is a statement that the project will not result in a significant adverse effect on the environment.

**Parcel Map 15-004.** The project is located in the Palo Cedro area on a 33.7-acre parcel located approximately 1,000 feet west of Maynard Road and adjacent to the north end of Skylark Lane. **Allen Knott** has requested approval of residential land division that would create, if approved, 4 parcels ranging in size from 5 acres to 8.73 acres and a 10-acre designated remainder parcel. The proposed parcels would be accessed from a proposed private road off Maynard Road. Staff Planner: Lozier.

**The public review period for the respective proposed Mitigated Negative Declaration or Negative Declaration will begin on Friday, September 2, 2016, and end Wednesday, October 5, 2016.** You are encouraged to submit comments regarding the proposed Mitigated Negative Declaration or Negative Declaration and/or the merits of the proposed project. You may do so by submitting written comments before the hearing, or attending and speaking at the hearing. To ensure consideration by the Commission, all written material concerning the proposed project should be submitted to the Planning Division prior to the end of the review period. Persons wishing to submit comments or appear before the Planning Commission are encouraged to first contact the staff planner listed.

Please note that any challenge of the proposed action in court may be limited to only those issues raised at the public hearing described in this notice, or in written correspondence delivered to the Planning Commission at, or prior to, the public hearing.

Some items may be considered routine and non-controversial. The hearing on these items will be expedited if no member of the Commission or audience wishes to comment or ask questions on the items.
