### **PRESENTATIONS**

### MENTAL HEALTH, ALCOHOL AND DRUG ADVISORY BOARD ANNUAL REPORT

Mental Health, Alcohol and Drug Advisory Board Chairman Sandra Tary presented the Advisory Board's 2011 Annual Report. Several projects and plans were completed in 2011, and priorities for 2012 include providing a forum for clients, family members, and other community members about needs and quality of service; promoting outreach and education regarding mental health and substance abuse services; monitoring the progress of the implementation of the Mental Health Services Act; collaborating with the National Alliance on Mental Illness Shasta County and other community organizations; and working with the HHSA Director, Alcohol and Drug Administrator, and the Adult and Children's Services Directors.

Rescinded the action taken on July 17, 2012 to approve a license agreement with Redding MSA Limited Partnership d.b.a. Verizon Wireless; and approved and authorized the Chairman to sign a retroactive license agreement with Redding MSA Limited Partnership d.b.a. Verizon Wireless in an annual amount of \$5,400 (paid in monthly installments) with five percent annual rent increases to provide space for existing radio communications equipment on Shasta Bally for a five-year period beginning July 1, 2010, with two optional five-year terms. Adopted Policy Resolution No. 2012-07, which amends Administrative Policy 8-400, *Health Insurance Portability and Accountability Act of 1996 (HIPAA) Privacy Policy*; and Administrative Policy 8-410, *Health Insurance Portability and Accountability Act of 1996 (HIPAA) Security Policy*. Reappointed Charles Adamo, Robert Miller, and John Page to the Board of Building Appeals for a two-year term to December 2014. (Clerk of the Board)

Approved the proposed calendar for the Board of Supervisors meetings for 2013. (Clerk of the Board)

Approved and authorized the Tax Collector to sell up to 100 tax-defaulted properties during a public auction on February 22, 2013, and re-offer at a lower minimum bid amount any parcel that does not sell. (Treasurer-Tax Collector-Public Administrator)

Approved and authorized the Chairman to sign a retroactive renewal agreement with Victor Treatment Centers, Inc. in an amount not to exceed \$250,000 to provide day treatment, day rehabilitation, mental health, and medication management services for eligible children for the period July 1, 2012 through June 30, 2013. (Health and Human Services Agency (HHSA)-Children's Services)

Adopted Resolution No. 2012-126, which ratifies the signature of the Sheriff on and the submission of the Fiscal Year 2012-13 Marijuana Suppression Program; and agrees to not supplant expenditures and abide by the statutes, regulations, and terms and conditions of the grant. (Sheriff)

### AGREEMENT: CITY OF TUCSON ONLINE SALE OF SHASTA COUNTY SURPLUS ITEMS

In response to questions by Supervisor Kehoe, Department of Support Services Director Michelle Schafer explained that Shasta County has contracted with the City of Tucson to utilize their online auction site to sell specific surplus County property. Shasta County will receive a higher price than if the item were to be auctioned locally. The proposed contract has been updated to reflect recent changes to California law regarding collection of sales tax.

By motion made, seconded (Kehoe/Baugh), and unanimously carried, the Board of Supervisors approved and authorized the Chairman to sign a renewal contract with the City of Tucson in the amount of seven percent of the gross sale of surplus County equipment to utilize the Public Surplus website for online surplus sales for Shasta County effective the date of signing until terminated by either party. # REFUNDING OF 2003 SERIES A COUNTY ADMINISTRATION BUILDING PROJECT BONDS SHASTA JOINT POWERS FINANCING AUTHORITY RESOLUTION NO. 2012-01

Administrative Fiscal Chief Bebe Palin presented the staff report, explaining that current low interest rates will allow Shasta County to save an estimated \$1 million or more by refinancing the outstanding revenue bonds for the Shasta County Administration Center. In response to a question from Supervisor Hawes, Ms. Palin noted that, since the rate of smoking has gone down, Tobacco Settlement Funding does not completely cover the bond payments; the refinancing should assist in that regard. Mrs. Palin noted that current law requires a roll call vote.

By motion made, seconded (Hawes/Baugh), and unanimously carried, the Shasta Joint Powers Financing Authority adopted Shasta Joint Powers Financing Authority Resolution No. 2012-01, which authorizes the defeasance and refunding of the 2003 Series A County Administration Building Project Bonds and the indenture in an aggregate principal amount not to exceed \$40,000,000 with a lease term ending not later than April 1, 2033, under certain specified conditions; approves and authorizes the execution and delivery of an indenture, an assignment agreement, site lease, a lease, a bond purchase agreement, an official notice inviting bids, a termination agreement, and escrow instructions; approves and authorizes County officers and staff to sign documents to execute the site lease, the lease, the bond purchase agreement, the official notice inviting bids, continuing disclosure certificate, termination agreement, escrow instructions, and other necessary or advisable documents; approves the preliminary official statement; approves the procurement of municipal bond insurance or guaranty; ratifies all actions taken by any officers, employees, or agents of Shasta County regarding issuance, delivery, or sale of the refunding bonds or connected agreements, documents, instruments, and certificates; designates officers for the refunding; and approves and authorizes the designated officers to sign documents necessary for the issuance and sale of the refunding bonds.

AGREEMENT: USA WASTE OF CALIFORNIA, INC.
RESIDENTIAL AND COMMERCIAL WASTE COLLECTION
INTRODUCTION OF ORDINANCE AMENDING
SHASTA COUNTY CODE CHAPTER 8.32

Public Works Director presented the staff report and recommended approval of the request. In response to questions by Supervisors, Supervising Engineer John Heath confirmed that USA Waste of California, Inc. provides a commercial and residential recycling program. USA Waste of California, Inc. Representative Matt Fryer clarified that, in reference to their vehicles operating on compressed natural gas (CNG), USA Waste plans to build a CNG fueling station that would eventually be available to the public for those people whose vehicles run on CNG.

By motion made, seconded (Hawes/Baugh), and unanimously carried, the Board of Supervisors introduced and waived the reading of an ordinance which amends Shasta County Code Chapter 8.32, *Refuse Collection and Disposal*; and approved and authorized the Chairman to sign a franchise agreement with USA Waste of California, Inc. to provide residential and commercial waste collection in the unincorporated area of Shasta County (excluding the Castle Rock School District and Intermountain areas) for the period December 14, 2012 through July 1, 2022.
