PROCLAMATION: CRIME VICTIMS' RIGHTS WEEK

At the recommendation of Chief Deputy District Attorney Josh Lowery and by motion made, seconded (Hawes/Baugh), and unanimously carried, the Board of Supervisors adopted a proclamation which designates April 22-28, 2012 as Crime Victims' Rights Week in Shasta County. Mr. Lowery introduced Crime Victims Assistance Center Program Director Angela McClure.

PRESENTATIONS

SHASTA-TRINITY NATIONAL FOREST MAINTENANCE LEVEL 3 ROADS

Shasta-Trinity National Forest Supervisor Sharon Heywood provided an update regarding the use of off-highway vehicles on Level 3 roads in Shasta County. Seventy-five letters were sent to interested members of the public regarding the process of changing Level 3 roads to Level 2 and 21 members of the public replied, stating issues of concern that included excessive dust and noise levels. Ms. Heywood discussed future steps to be taken and confirmed that she will provide continued updates.

PRESENTATION: SHASTA PUBLIC LIBRARY SYSTEM

City of Redding Community Services Director Kim Niemer provided an update on the Shasta Public Library System. The libraries provide increased internet services, which has in turn increased visits for that service. The three Shasta County libraries utilized over 28,000 volunteer hours of service in 2011. In addition, an online tutoring program is now available for students.

Chairman Moty advised that the items regarding the amendment to the agreement with the Judicial Council of California, Administration Office of the Courts is pulled for discussion.

CONSENT CALENDAR

By motion made, seconded (Baugh/Hawes), and carried, the Board of Supervisors took the following actions, which were listed on the Consent Calendar, as amended (Supervisor Kehoe voted no on the proposed increase of appropriations and revenues to utilize Hatchet Ridge Community Benefit Agreement funds.):

Approved budget amendments increasing appropriations and revenues by \$40,000 in the Library and Building budgets to utilize Hatchet Ridge Community Benefit Agreement funds for a preliminary design study for a Burney Library building; and approved the transfer of funds from the Resource Management fund to the Library fund. (Administrative Office)

In accordance with Assembly Bill X1-26, appointed Supervisor Les Baugh and Patrick Wallner to serve as Shasta County's representatives to the Oversight Board of the Successor Agency to the Anderson Redevelopment Agency. (Administrative Office)

In accordance with Assembly Bill X1-26, appointed Supervisor Glenn Hawes and Jeff Avery to serve as Shasta County's representatives to the Oversight Board of the Successor Agency to the Redding Redevelopment Agency. (Administrative Office)

In accordance with Assembly Bill X1-26, appointed Supervisor Linda Hartman and Roger Lawson to serve as Shasta County's representatives to the Oversight Board of the Successor Agency to the Shasta Lake Redevelopment Agency. (Administrative Office)

Approved and authorized the Chairman or, when the Chairman is unavailable, the Vice Chairman to sign an agreement with Gallina LLP in an amount not to exceed \$73,150 for the first fiscal year to prepare the annual County Financial Audit for the fiscal years ending June 30, 2012 through 2014, with two optional one-year renewals. (Administrative Office)

Adopted a proclamation which designates April 2012 as Fair Housing Month in Shasta County. (Board Matters)

Approved the minutes of the meetings held on February 28 and March 6, 2012, as submitted. (Clerk of the Board)

Adopted Salary Resolution No. 1403, which repeals Salary Resolution No. 1402; ratifies any wages paid in accordance with Salary Resolution No. 1402; adds seven positions and deletes seven positions in various departmental budgets retroactively effective March 11, 2012; deletes eight positions in the Public Works-Roads budget (including one position with a sunset date of December 31, 2012) effective July 1, 2012 due to new Regional Transportation Planning Agency staffing arrangements; modifies a footnote regarding HHSA janitorial services and ground maintenance duties effective March 11, 2012; and adds a footnote regarding additional pay for the Property Tax Specialist-Public Administrator Assistant I/II classification effective March 11, 2012. (Support Services)

Approved and authorized the Chairman or, when the Chairman is unavailable, the Vice Chairman to sign a renewal agreement with North Valley Behavioral Health, LLC in an amount not to exceed \$900,000 for the balance of Fiscal Year 2011-12 and an amount not to exceed \$1,900,000 for Fiscal Year 2012-13 to provide psychiatric inpatient services from the date of signing through June 30, 2012, with one automatic one-year renewal; and approved and authorized the Health and Human Services Agency Director or his/her designee to approve, in writing and in advance, changes to the rates not exceeding 10 percent over the original rate or not increasing total compensation payable. (Health and Human Services Agency (HHSA)-Adult Services)

AMENDED AGREEMENT JUDICIAL COUNCIL OF CALIFORNIA EXTENDING DATE OF VACATION OF PUBLIC SAFETY BUILDING

In response to questions by Supervisor Kehoe, County Administrative Officer (CAO) Larry Lees stated that the property acquisition agreement with the Judicial Council of California, Administrative Office of the Courts was for continued Shasta County usage of the Public Safety Building, located at 1525 Court Street, until June 30, 2012. The agreement is being amended to allow County use of the building through December 31, 2013 as the new Superior Court has not yet been built for Court personnel to relocate.

By motion made, seconded (Hawes/Kehoe), and unanimously carried, the Board of Supervisors approved and authorized the Chairman or, when the Chairman is unavailable, the Vice Chairman to sign an amendment to the property acquisition agreement with the Judicial Council of California, Administrative Office of the Courts extending the date Shasta County must vacate the Public Safety Building to December 31, 2013.
