

**ORDINANCE NO. 758**

**AN ORDINANCE OF THE BOARD OF SUPERVISORS  
OF THE COUNTY OF SHASTA  
SETTING FEES TO BE CHARGED BY THE PROBATION DEPARTMENT  
AND REPEALING ORDINANCE NO. 696**

The Board of Supervisors of the County of Shasta ordains as follows:

**SECTION I.** Counties are permitted to charge and collect certain fees from juvenile and adult offenders pursuant to certain California Government and Penal Codes.

**SECTION II.** The County of Shasta previously adopted Ordinance No. 696 which established certain fees and charges as permitted at the time of the adoption of Ordinance No. 696.

**SECTION III.** California adopted new legislation that, effective July 1, 2021, eliminates the ability of counties to charge and retroactively collect certain fees from adult offenders.

**SECTION IV.** The ability of counties to charge and collect certain fees from juvenile offenders was repealed effective January 1, 2018.

**SECTION V.** The fees set forth in Attachment A attached hereto and incorporated herein reflects those fees that continue to be permitted to be charged and collected.

**SECTION VI.** This ordinance does not establish new fees and does not increase or extend fees that were adopted by Ordinance No. 696.

**SECTION VII.** This ordinance repeals Ordinance No. 696.

**SECTION VIII.** This ordinance shall take effect and be in full force and effect 30 days after its passage. The Clerk shall cause this ordinance to be published as required by law.
