**AN ORDINANCE OF THE BOARD OF SUPERVISORS OF THE COUNTY OF SHASTA  
AUTHORIZING AN AMENDMENT TO THE CONTRACT BETWEEN THE BOARD OF  
SUPERVISORS OF THE COUNTY OF SHASTA AND THE BOARD OF ADMINISTRATION  
OF THE CALIFORNIA PUBLIC EMPLOYEES' RETIREMENT SYSTEM**

**SUMMARY OF ENACTED ORDINANCE:** In summary, the ordinance amends the Retirement Contract between the Board of Supervisors of the County of Shasta and the Board of Administration California Public Employees Retirement System (CalPERS) to adopt Section 20516 (Employees Sharing Additional Cost) of one percent (1%) of the employer's contribution to retirement costs for miscellaneous members in the General Teamsters Local #137, Shasta County Mid Management Bargaining Unit (MMBU), United Public Employees of California (UPEC) – General Unit, Unrepresented Managers and Unrepresented Confidential Employees, one percent (1%) of the employer's contribution to retirement costs for county peace officers in the Deputy Sheriff's Association (DSA) – Correctional Officers, Unrepresented Managers and MMBU Groups, and one percent (1%) of the employer's contribution for local sheriff members in the Shasta County Sheriff's Administrative Association (SAA), Shasta County DSA - Deputy Sheriff, Sergeant and District Attorney Investigator, and Unrepresented Managers groups. The ordinance also authorizes the Chairman to sign the contract for the County of Shasta upon receipt of the final document from CalPERS.
