PS: A Prioritization Score developed with the Emissions and Potency Procedure in the CAPCOA Facility Prioritization Guidelines.

HRA Results: Health Risk Assessment results are displayed as A/B/C where A = Cancer Risk per million, B = Chronic Hazard Index, and C = Acute Hazard Index. If these values are listed it means they were used to categorize the facility instead of the Prioritization Scores.

Prioritization Updated: This column shows the Reporting Year in which the facility's categorization was last changed.

USF: The Update Summary Form is the first document facilities due for quadrenial AB 2588 reporting must submit. The USF indicates if the facility has made any changes which may affect their emissions. If changes are found, then the facility may be required to submit an Update EI Plan followed by an Update EI Report.
