**BLOODBORNE PATHOGENS EXPOSURE CONTROL TRAINING PROGRAM EVALUATION**

The Shasta County Environmental Health Division (SCEHD) is the local enforcement agency charged with the implementation of the California Safe Body Art Act. This law defines requirements for Bloodborne Pathogens Exposure Control Training, and states that training shall be conducted by a person or persons knowledgeable in exposure control and infection prevention in the body art setting and who are approved by the local enforcement agency. The training program shall be updated when infection control issues, changes in the practice of body art, or new technology warrants modification.

Complete this evaluation form and submit to SCEHD along with a brief biography or resume, a copy of your coursework documentation, and a copy of your presentation in order to have your training program reviewed. An hourly rate will be charged once the review is completed. Payment shall be made prior to written approval or denial of the training program.

The signage required for biohazardous materials and the importance of properly labeling chemicals and supplies.

Hepatitis B vaccine, including safety and accessibility.

Discussion of what constitutes a bloodborne pathogen exposure (BBPE) incident, including all of the following:

Examples of BBPE, how exposure occurred, and actions necessary to prevent/minimize future exposures.

Risk of infection following a bloodborne pathogen exposure incident.

Procedures to be followed after an exposure incident, including medical follow-up.

Opportunities for interactive questions and answers with the instructor.
