<b>Situation Summary:</b>	<ul style="list-style-type: none"> <li>We have 8 new cases today. Six had symptoms and none are hospitalized. They are a boy under 13, a girl under 13, a man in his 20s, a woman in her 20s, a man in his 40s, two women in their 40s, and a woman in her 80s.               <ul style="list-style-type: none"> <li>We are sorry to have to report a death today. The coroner has confirmed that a man in his 80s has died due to COVID-19.</li> </ul> </li> <li><b>About the numbers:</b> We are reporting some new numbers today. “Active cases” include people in isolation and people who are hospitalized. “Released from Isolation to Date” includes people who were once positive, but have passed their infectious period and have been removed from isolation. People’s experience with COVID-19 is varied, so some of these people are back to full health, while others have lingering health problems.</li> <li>Anyone can be tested for COVID-19. If you have symptoms, contact your healthcare provider or call (530) 225-5591 to access testing in Redding or the Intermountain area. People with or without symptoms can sign up for testing at Shasta College. Go to <a href="https://lhi.care/covidtesting">https://lhi.care/covidtesting</a>. Appointments are required.</li> </ul>
